

Written Procedure - Commission Implementing Decision amending the Annex to Implementing Decision 2014/178/EU as regards the areas in

Lithuania, Latvia and Estonia under restriction for African swine fever

(Doc SANCO/7075/2014)

Message:

The Commission intends to adopt an implementing decision amending current regionalisation for African swine fever (ASF) laid down in Commission Implementing Decision 2014/178/EU. This follows its latest amendment by Commission Implementing Decision 2014/448/EU which was voted by the Standing Committee on Plants, Animals, Food and Feed on its meeting of 4 July 2014.

The amendments currently proposed relate to the areas covered in the different parts of the Annex to Decision 2014/178/EU to adapt the regionalised areas to the evolution of the epidemiological situation in Lithuania and Latvia. This requires establishing a new area on the eastern border to Lithuania, to adapt the already existing regionalisation in the eastern part of Latvia and to setup a new restricted area that covers both Latvia and Estonia. The definition of the type of area (Part I, II or III) is related to the level of risk that it presents for EU. The currently proposed amendments have already been discussed and agreed with the concerned Member States. For information purposes only, please find attached an indicative map showing the changes from the current situation.

Due to time constrains and in order to avoid convening a special meeting of the Standing Committee on Plants, Animals, Food and Feed for one item, I would like to use the possibility of a written procedure as foreseen in Article 8 of the standard rules of procedure of the Standing Committee on Plants, Animals, Food and Feed.

Please find attached document SANCO/7075/2014 on a draft Commission Implementing Decision amending the Annex to Implementing Decision 2014/178/EU as regards the areas in Lithuania, Latvia and Estonia under restriction for ASF.



### THE EUROPEAN COMMISSION.

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Council Directive 89/662/EEC of 11 December 1989 concerning veterinary checks in intra-Community trade with a view to the completion of the internal market1, and in particular Article 9(4) thereof,

Having regard to Council Directive 90/425/EFC of 26 June 1990 concerning veterinary and zootechnical checks applicable in intra-Community trade in certain live animals and products with a view to the completion of the internal market2, and in particular Article 10(4) thereof,

Having regard to Council Directive 2002/99/EC of 15 December 2002 laying down animal health rules governing the production, processing, distribution and introduction of products of animal origin for human consumption3, and in particular Article 4(3) thereof,

#### Whereas:

- Commission Implementing Decision 2014/178/EU<sup>4</sup> lays down animal health control (1)measures in relation to African swinc fover in certain Member States. The Annex to that Decision demarcates and lists certain areas differentiated by the level of risk bused on the epidemiological situation. That list includes certain areas of Italy, Poland, Lithuania, Latvia.
- Since 26 June 2014, the presence of African swine fever has been identified in feral (2)pigs and domestic pigs in Latvia. The likely source of the introduction of African swine fever virus is from neighbouring third countries that have reported the occurrence of that disease. Several outbreaks in domestic pigs were reported near the Latvian border with third countires and cases in feral pigs were found in the same area, up to 30 kilometers from that border. In addition, one outbreak in domestic pigs and two cases in feral pigs were reported in Latvia near the Estonian border. New findings

were also reported by Lithuania, notably one outbreak in a pig holding in the Eastern part of the country.

- (3) The evolution of current epidemiological situation should be considered in the assessment of the risk represented by the animal health situation in Lithuania, Lativa and in neighbouring third countires. In order to focus animal health control measures and to prevent the spread of that disease as well as to prevent any unnecessary disturbance to trade within the Union and to avoid unjustified barriers to trade by third countries, the Union list of areas subject to the animal health control measures provided for in Implementing Decision 2014/178/EU should be amended and take into account the current animal health situation as regards that disease in Lithuania and Latvia.
- (4) It is therefore necessary to amend the Annex to Implementing Decision 2014/178/EU to include the relevant areas of Lithuania, Latvia and Estonia.
- (5) Implementing Decision 2014/178/EU should therefore be amended accordingly.
- (6) The measures provided for in this Decision are in accordance with the opinion of the Standing Committee on Plants, Animals, Food and Feed.

Article 1

The Annex to Implementing Decision 2014/178/EU is amended in accordance with the Annex to this Decision.

Article 2

This Decision is addressed to the Member States.
